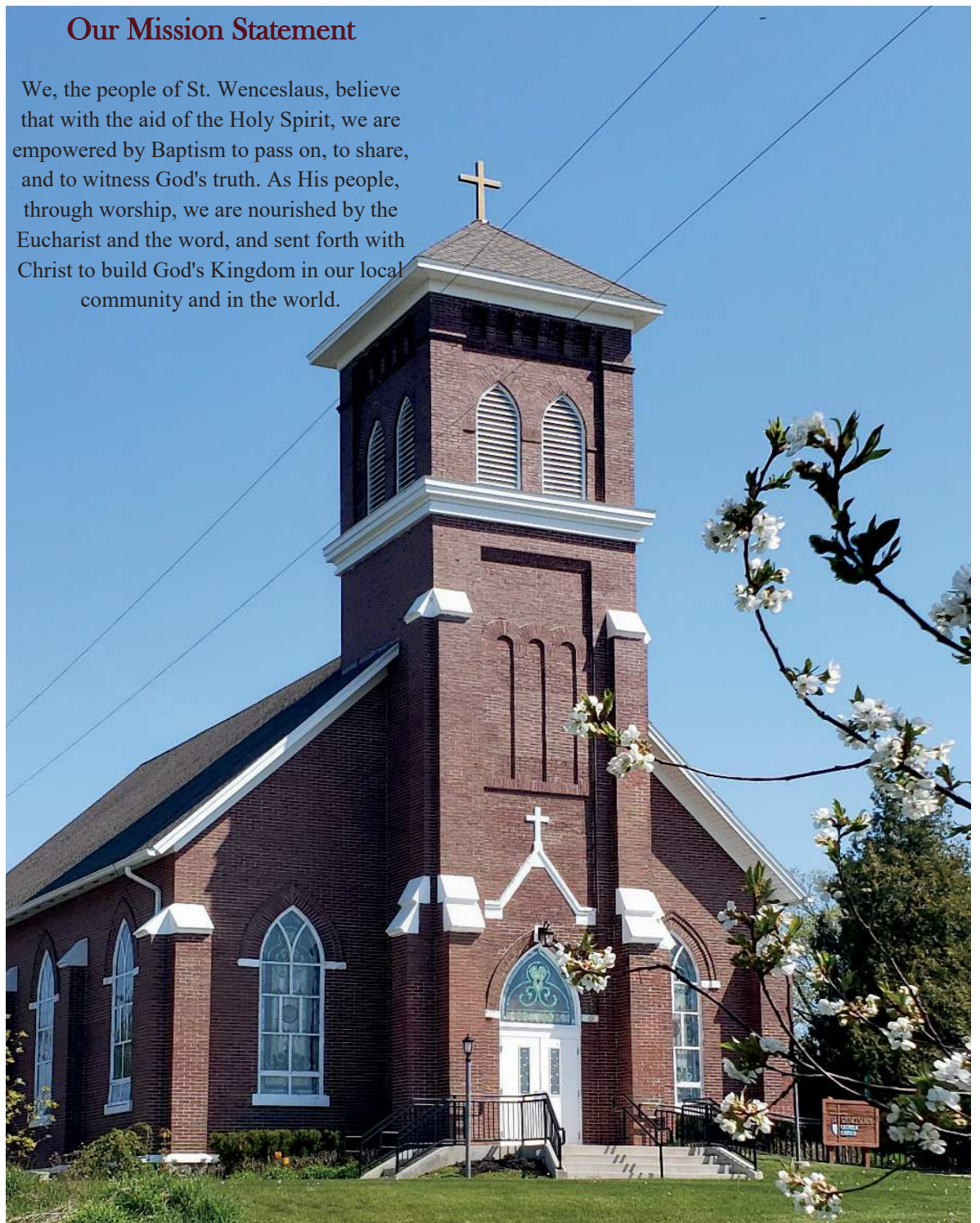

**Dear Friends in Christ,**

In today's liturgy, from John 6:51-18, Jesus tells the Jewish crowd that He is the living bread that came down from heaven; whoever eats this bread will live forever. The bread that He will give is His flesh for the life of the world. The Jews quarreled. Jesus said again: "Unless you eat the flesh of the son of Man and drink His blood, you do not have life within you."

Jesus is telling us about the Eucharist, and how important it is to receive. It is truly His body and blood. It is not just a symbol, but His real presence. It is as real to us as He was to the apostles two thousand years ago. We can physically touch Him, talk to Him, sit in His presence, and enjoy His company.

Jesus tells us this is the way to have eternal life, the life of Christ within us. Through eating His flesh and drinking His blood we remain in communion with Christ and, through Him, we remain in communion with the Father. This gives us peace of mind here and for all eternity. Accepting Christ in the Eucharist, accepts Christ into our daily life. Walk with Him as the Apostles did.
